- Motion to amend section 3.4 of the Election By-Laws to state that:

 'No candidate may run on a ticket. A ticket is defined as more than one (1) candidate running under an express common name or organising co-promotion for the purposes of the election. Candidates may not make any reference to any other candidate for the purposes of the election in published material.' The wording of this provision may be amended at the committee meeting.
 - Any other way to promote running for the LSS without tickets?

- Can approach people you know and encourage them if you think they have the right skill set
- What are other universities doing?
 - · Macquarie: cannot in any way publicise yourself
 - · USyd: can only run on a ticket
 - · More particular to that university's environment
- More level playing field if there are no tickets
 - Many capable people didn't run because there was no room left on tickets and they felt they could not compete
 - People got pushed into roles they weren't too keen on because of gaps in tickets
- We are a functional body so no point in having tickets (political)
- Looking at polling data, people had to be on a ticket to be on the committee
- People may run a ticket just for the experience, external to the LSS
- Running on a ticket, you could read everyone's ideas and experience
 in one area LSS publishes this anyway
- When elections are divided along ticket lines, it can get nasty
- Big concern has been continuity because we turnover 100% every year
 more likely to get fresh faces on a ticket push for difference does
 not help continuity
- ANUSA had an expression of interest form was it meritorious this year?
 - · Weren't as utilised as they should have been
 - · Popular people get shoulder tapped anyway
- If shoulder tapping, you will try to put people in positions to fill a ticket
- Another issue with tickets becomes a competition about marketing

- With tickets, you get a lot of votes because you'll vote for people on your ticket
- If we shut tickets down, it turns to how well you can promote yourself
 - · People can borrow LSS resources, e.g. DSLR camera
