#### PRESIDENT

- Overall Reflections on the Year

  - Two members of our current LSS Committee on next year's ALSA Committee.
- New Developments
  - Sir Harry Gibbs Constitutional Law Moot to be held and hosted by the ANU for 2025-2027
  - New Partnership with UN Society (both at ANU and UNSW) to kick off next year, with goal of collaborative intervaristy model UN competitions

## EVENTS - presented by Bita as Hugh was absent

- Kicked off the semester with welcome back drinks at PJ's in the City.
- Had a very decent turnout sold 57 tickets
- The bar tab started at \$750, decided to extend it to \$1000.
- Really nice to have everyone together before the semester properly started, good to see some familiar faces (a handful of law campers)
- Really happy with how law ball turned out, everything came together amazingly
- Upcoming events

## SOCIAL JUSTICE

- 3 major panels:
  - Legal Launchpad
  - LGBTQIA\*+ Issues in the Law
  - Social Justice Careers Evening
- 2 podcasts:
  - Nick Mann (personal injury lawyer)
  - Shane Rattenbury (Attorney General)
- Social Justice Celebration Dinner
  - Held at Symposium and student speaker (Ben Yates) enabled it to be more accessible

#### SPONSORSHIP - presented by Bita as Charli DG was absent

- All sponsorship packages followed relatively similar trend of 2023 packages.
- Lost only 1 general package sponsor and increased our ad hoc sponsors.
- Meetings over the year have shown interest in more one-on-one displays of firm business, i.e., catered lectures a potential to add to the prospectus in 2025.
- Email blasts were on par in popularity to FB posts, appeared to be an increase from 2023.
- Working alongside other portfolios has been beneficial, sponsors have been well-engaged with the actual event runners (VPs) - should promote this practice in coming years.
- Sponsorship equipment relationships has been successful, may need to focus attention towards maintaining these relationships through director in 2025

FINANCE PRESENTATION

- Getting more expensive to run things financially but income similar
- Need to make finance more lean; budget increases for some portfolios
- Still in a surplus; closeness caused by decision to wear ALSA costs, which won't be a problem next year since it's in CBR
- Might have to start digging into savings
- 157k now at 162k
- Waiting on tax return from ATO
- Budget breakdown
  - Admin largely on track; spent more on committee meetings; if we bought more merch, would have been over
  - o ALSA large increase in spending this year but won't be an issue next year
  - Careers; clerkship night double budgeted price since Kambri increased prices; generally okay for more spending here
  - Competitions; significant underspend especially for competitor fund, maybe advertising more and policy guide
  - Education; on par with budget
  - Equity; underspent, reflects big increase in initiative allocation because of new positions, maybe spending more in the future can increase engagement
  - Social Justice; underspend, SJ did more events
  - Events; law ball overspend by \$500 which is quite good, worth discussing how much we spend on ad hoc drinks but these are good for engagement
  - o Finance; unavoidable expenses, on par, BAS consistent, tax TBC
  - JD events; underspent but awaiting reimbursements
  - Peppercorn; more expensive but got \$2k more from fund, maybe increase fund in future but generally costing more to run than previous years
  - Sponsorships; no expenses
  - o Miscellaneous; none yet; Law Revue accounted for elsewhere
- Almost all revenue from sponsorships
- 130k from sponsorships; issue is similar overall amount coming in but more expensive to run things
- Law ball more sales raise in price due to raise in venue price; no committee discount; investigating other venues would be good
- Law camp made more money than expected, more sales, becoming a more established event
- Merch not much made
- Events generally made what we expected
- Will probably sit with a 10k profit at the end of the year, good but lower than usual
- Association Report
  - Note it's for 2023
  - Made 180k in 2023 and spent 135k
  - Numbers a bit off because we don't operate in same calendar years
  - Law ball still highest spending event
  - Sponsorship money stars coming in December and not much spending until uni starts
